The reference entry starts with the author's last name followed by initial (s).

A Quick Guide to Harvard Referencing | Citation Examples

Referencing is a system that allows you to acknowledge the sources of information you use in your writing. If you do not reference your sources, you are plagiarising. You must provide a reference whenever you quote, paraphrase or summarise someone else's ideas, theories or data.
