CLAIM FOR COMBAT-RELATED SPECIAL COMPENSATION (CRSC)

You can send in a 12E for CRSC reconsideration, but you already receive the ceiling for your case. If you do submit documents to your service, you new award from the VA will be needed as well as all previous awards of CRSC.

Increase in CRSC - Veterans Benefits Network

If you have already applied for CRSC, but disagree with the CRSC decision, you can request a reconsideration of the decision. For the Army, submit CRSC Form 12e. For the Navy and Marines, submit NCPB Form 1850-7. For the Air Force—they always have to be different—you have to call them to get application instructions: 1-800-525-0102.

From the Army: In the case that a claimant does not agree with that determination, the applicant can submit a request to the U.S. Army CRSC Office for reconsideration of a decision. The applicant must submit a Reconsideration Request Form (CRSC Form 12e) with new supporting documentation or other relevant information.

Assuming you have been denied twice (original and reconsideration), the following will apply: Full disclosure: This is a cut and paste and is available on the Army HRC page. If the CRSC reconsideration is disapproved, a claimant may submit an appeal to the Army Review Boards Agency (ARBA). Appeals to ARBA must be submitted using DD Form 149.
